Important Notice About Rewards

GRWB is currently in its pre-token phase. The official GRWB token has not yet launched and is not available for purchase, trade, or exchange.

To incentivize civic participation and platform testing, GRWB is temporarily distributing **SUI tokens** from a designated **SUI Slush Wallet** as **non-investment-based, good-faith rewards** for verified poll participation.

Legal Status of Rewards

- **These rewards are not an investment.** You are not purchasing or acquiring a stake in GRWB, XPoll Labs, or any affiliated DAO entity.
 - The SUI token is distributed solely as a **participation-based reward** for completing verified tasks (e.g. taking polls).
 - Participation is **not a condition for future token airdrops, whitelist access, or investment returns**.
 - Rewards are distributed **without expectation of profit** and have no bearing on any future GRWB token distribution or governance rights.

GRWB Compliance Position

1. **No Token Sale:** GRWB has not conducted, and will not conduct, a public or private sale of GRWB tokens at this time.
2. **Not a Security Offering:** The use of SUI tokens is for community participation only and is not structured to represent securities or investment contracts.
3. **Jurisdictional Limitations:** Participation in the rewards program may be limited in jurisdictions where such incentives are regulated or prohibited. It is your responsibility to ensure compliance with your local laws.
4. **No Guarantees or Promises:** GRWB makes no guarantees regarding the value, transferability, or continued distribution of SUI tokens under this program. This program may be modified or discontinued at any time without notice.

Eligibility and Verification

To maintain the integrity of our platform:

- Participants may be required to verify their wallet, location, or identity (KYC) before receiving SUI token rewards.

Wallets and Custody

- Rewards are distributed to self-custodied wallets provided by the participant.
- GRWB is **not responsible for lost, inaccessible, or misdirected SUI tokens** once transferred to the provided address.
- GRWB does not custody or provide custodial services for users' SUI wallets.


Transition to GRWB Token

Upon launch of the GRWB token:

- Participants in the SUI rewards program will **not automatically receive GRWB tokens**.
- There will be **no conversion or exchange mechanism** between SUI rewards and GRWB tokens.
- GRWB reserves the right to create future participation-based programs at its sole discretion.
